#### Theft, loss or misuse of card

If the Card is lost, stolen or misused by someone who obtained it without your consent, you may be liable for up to £0 of any loss to us. If it is misused with your permission, you will probably be liable for ALL losses. You will not be liable to us for losses, which take place after you have told us of the theft, etc provided you confirm any oral message in writing within 7 days. However the Card can also be used under an agreement to which this protection does not apply. As a result, there may be circumstances in which you will have to pay for all the losses to us.
