- If you do not get this in place by the date your vehicle tax runs out, your Direct Debit will not renew and you will need to tax your vehicle.

More about your Direct Debit renewal

Your Direct Debit renews automatically when the following is in place on the date the tax runs out:

- A valid test certificate (MOT/PSV/GVT)
- Insurance (vehicles registered at a Northern Ireland address)

Question?	Answer
Why have I received this letter?	We needed to let you know that you need to get a valid test certificate (MOT/PSV/GVT) and/or insurance (NI only) before the date the tax runs out so that we can renew the Direct Debit for your vehicle tax.
This letter says I don't have an MOT and/or insurance (Northern Ireland only), is my current tax still valid?	Your current tax is valid until the date shown on the front of the reminder, however if the MOT/insurance isn't renewed before the date the tax runs out, the Direct Debit will not renew and the vehicle will become untaxed after this date.
I have the MOT booked for the end of the month, will my Direct Debit renew?	Yes, if your vehicle passes the MOT the Direct Debit will renew. Your new payment schedule will be issued within a few days, your first payment will be delayed in being taken out but you can still drive from the 1st of the month.
I've just insured my vehicle/had an MOT, what do I do?	Nothing, the Direct Debit will automatically renew. Your first payment will be delayed in being taken out but you can still drive from the 1st of the month.
My vehicle has failed the MOT, what should I do now?	The vehicle must have a valid MOT in place on the date the tax runs out for the Direct Debit to be renewed. If this is not possible, you will need to tax the vehicle after you get an MOT. If you do not get an MOT, you will need to keep the vehicle off road and make a Statutory Off Road Notification (SORN).
My vehicle doesn't require an MOT as it is MOT exempt (Taxi etc)	Part of the criteria for Direct Debit renewal is the presence of an MOT for vehicles over 3 years old (or 4 years in Northern Ireland). As your vehicle is MOT exempt the Direct Debit will not renew, you will need to set up a new Direct Debit using your V5C.
