From 1 April 2010, all businesses with an annual (VAT exclusive) turnover of £100,000 or more must file their VAT Returns online and pay any VAT due electronically. Any business registering for VAT on or after that date will also have to file online/pay electronically, whatever its turnover.

The first three facts are on your certificate of VAT Registration (VAT 4); the other two facts are on your last filed VAT return. (*Note:* If you have filed your paper VAT return in the past 2 weeks, please also bring along details from your previous return)
