Set up your 'My account' (you may already have done this for renewing a parking permit or managing a smart visitor permit) and add council tax / benefits. It will allow you to access your information online and is available around the clock even when we are closed. It can be used to check your account information, amend a direct debit, apply for sole occupier discount etc.



## You pay your council tax bill by direct debit

Direct debit arrangements carry over from one year to another, unless you cancel them. If you move within the borough, we should be able to continue the direct debit on your new property. If your bank details change please let us know. You can do this online see section above or call 020 8753 6681. The front of this bill details the amounts and dates we will request payment from your bank or building society. Payments by direct debit are taken on either 1<sup>st</sup>, 8<sup>th</sup>, 15<sup>th</sup>, 21<sup>st</sup> or 28<sup>th</sup> of the month.

### The direct debit guarantee

This guarantee is offered by all banks and building societies that take part in the direct debit scheme. The efficiency and security of the scheme is monitored and protected by your own bank or building society. If the amount to be paid or the payment dates change, the London Borough of Hammersmith & Fulham will notify you 10 working days in advance of your account being debited or as otherwise agreed. If an error is made by London Borough of Hammersmith & Fulham or your bank or building society, you are guaranteed a full and immediate refund from your branch of the amount paid. You can cancel a direct debit at any time by writing to your bank or building society. Please also send a copy of your letter to us (address overleaf)
